## **WHO CAN APPLY?**

Anyone as long as they are under 30 years old on the 31st December in the year that they are applying, are employed by a CBA member company and have been nominated by their Line Manager / CEO

## **ISN'T THIS JUST ANOTHER RESPONSIBLE CARE AWARD?**

No, this is a unique award that is not part of the formal Responsible Care programme or process (although obviously all CBA Members should be practising Responsible Care as standard!)

## **WHAT IS THE POINT OF THIS AWARD?**

CBA wants to encourage the development of young people and recognise excellence within our sector and is looking for the young superstars of tomorrow that have already significantly contributed to and enhanced your business. Celebrating our member's extraordinary young people, the industry's potential future leaders, is a great start

## **APPLYING IS GOING TO INVOLVE LOADS OF FORM FILLING THAT I JUST DON'T HAVE TIME FOR..**

To be honest, the person being nominated does most of the work! They would need to submit an entry statement explaining their role in your company, their employment history, experience and why they feel they should win the award. The Line Manager / CEO just needs to make the nomination and support the applicant's entry!

## **WHAT DOES THE WINNER GET?**

Not only will they be presented with an award at CBA's prestigious Annual Lunch in front of colleagues and peers but the winner will also be invited, in the 12 months following their win, to attend a CBA Council meeting, one of each of the following CBA Committee meetings (Responsible Care, HSE, Logistics and Marketing) and form a Communications Panel together with the other short-listed entrants to help engage other young people in our sector (Not forgetting of course serious 'bragging rights' for the winner and their company!!)

## **WHO DECIDES WHO THE WINNER WILL BE?**

The winner will be decided by a judging panel of representatives of CBA member companies (excluding those companies who have applied for the award of course!)
