The UK left the European Union at the end of 2020 with the UK REACH regulation being enacted into UK law. Since then, it has been subject to a number of deadlines for action, revisions to legal aspects and a myriad of guidance following questions raised by industry. There is still a large degree of confusion as to what to do and how to do it.

The first registration deadline for companies within UK REACH is the 27<sup>th</sup> October 2026 and will require companies to fulfil their registration obligations to continue to trade in a substance. The next deadlines follow in 2028 and 2030, so it is key that companies understand their obligations, agree a 'way forward' and prepare accordingly.

This seminar will provide a ***basic level of information*** to help refresh knowledge and provide a snapshot of where we are or to provide 'new' knowledge to those entering REACH for the first time.

It is aimed at all levels within a company as REACH is not just restricted to technical departments within organisations.
