Why attend?

Many companies continue to be found in breach, and subject to financial penalties, for failing to comply with the packaging waste regulations.

Though the Producer Responsibility Obligations (Packaging Waste) Regulations have been in place for some time, they continue to cause misunderstandings concerning their day-to-day application.

Any company with a turnover of more than £2million and handling more than 50 tonnes of obligated packaging a year needs to consider if it is compliant with these regulations.

CBA will be joined by a specialist from a packaging compliance scheme and a CBA member who makes a direct registration.

Who should attend?

The workshop is suitable for all levels of personnel requiring a practical knowledge of packaging waste compliance – including regulatory compliance specialists.

It will be useful to those specifically responsible for ensuring compliance and to those requiring a working knowledge of the regulations and their practical operation.

- ◆ *Who is obligated?*
- ◆ *What packaging is included?*
