Why attend?

(EU) 1907/2006/EC (EU REACH) has been 'copied across' into UK law and a series of Statutory Instruments (SI) **enacted**. UK preparations have been underway for a number of years, due to the various aborted deadlines, but specific details were still not clear even at the end of the transition period.

By building on the successful November 2020 event, updating where new information has come to light, the seminar will provide up to date advice on the implementation and operational processes. It will also serve as a reminder in advance of the first notification deadline (30 April 2021)

Companies that do not have any obligations under EU REACH may discover GB REACH will change how they need to manage chemical portfolios within the UK and Europe. Then there is the fact that Northern Ireland will remain part of EU REACH after the end of the transition.

Who should attend?

This seminar will provide a **basic level insight** relating to the REACH process in the UK Brexit. It will use a number of scenarios to illustrate points and help identify potential weaknesses in a company's preparations

It will be aimed at all levels within a company as REACH is not just restricted to technical departments within organisations.
