At the end of the Brexit transition period GB implemented their own biocidal products regulation. The existing EU Biocidal Products Regulation has been carried over into GB law but amended to enable it to operate effectively in GB.

Companies placing biocidal products on the market in GB may need to take action to remain compliant with this new GB regulation.

In the half-day seminar, CBA's Technical Team will cover the main points of the regulation and what steps companies need to take to remain compliant.
