A PROUD HERITAGE

We were founded in 1923 as the British Chemical and Dyestuffs Traders Association through the amalgamation of the British Chemical Trade Association and the Chemical and Dyestuffs Traders

Association

At the first meeting of the newly formed Executive Committee, it was stated that this was "the foundation of a powerful Merchant organisation, which would prove of great value to its members" and its aims and objectives included dealing with a shortage of dyestuffs following World War I and promoting the "cause of Free Trade" with countries such as India and Russia

By 1980, our remit had gone well beyond dyestuffs and our name was changed to the British Chemical Distributors and Traders Association. In 2006, as our membership had continued to expand and diversify, we were further renamed the Chemical Business Association

Since then, our influence and presence has continually increased with our mission gaining even more importance as result of Brexit. Our present-day aims and objectives include providing initiatives and contributions towards legislation, to support and develop the ability of our members to trade nationally and globally in an economically viable and sustainable environment, whilst also raising and promoting the profile of the chemical supply chain and its vital role in society. We are proud that our membership still includes some of our founding members along with all types and sizes of businesses operating in the chemical supply chain
