**Afternoon Session: Overcoming the Challenges of
Scope 3 Emissions Reporting**

**Presenter: George Anderson, Senior Carbon Specialist,
Bureau Veritas**

Scope 3 emissions, which occur throughout a company's value chain, typically account for the majority of a business's emissions. Accurately measuring and reporting Scope 3 emissions is crucial for identifying emission hotspots, managing risks, building trust with stakeholders, and supporting decarbonisation efforts.

However, there are several challenges to accurately measuring Scope 3 emissions, including the scale of emissions in large value chains, lack of accurate data, varying methodologies, and the resource-intensive nature of calculations.

In this session, George Anderson will examine these challenges, explore their implications, and discuss potential ways to overcome them. Participants will gain a deeper understanding of Scope 3 emissions reporting and strategies to improve their organisation's approach.
